The committee approved the proposal to change the name of the Daniel B. Warnell School of Forest Resources to the Daniel B. Warnell School of Forestry and Natural Resources under the condition that this name change does not preclude any other school or college from using the term "natural resources" in any of their current or future academic, research, or extension programs, activities, facilities and campuses. The proposal will be submitted to the Executive Committee of University Council for consideration.

The committee approved a proposal for an Undergraduate Certificate in Music Business pending approval by the Franklin College of Arts and Sciences Senate. The proposal will be submitted to the Executive Committee of University Council for consideration.

The committee approved a proposal for an Area of Emphasis under the Fashion Merchandising major (B.S.F.C.S.).

The committee received a draft reorganization policy as well as a draft policy to establish new schools, colleges and departments. The UCC members were asked to review and circulate the proposals for feedback. The proposal will be sent to curriculum committees of individual schools and colleges for input as well.

The General Education Subcommittee reported that they met three times since the last UCC meeting to begin work on the General Education Task Force recommendations.
