The University Curriculum Committee met on September 14, 2011, at 3:00 p.m. in room 315 New College. Minutes of the March 23, 2011, meeting were approved.

The committee approved the following proposals which have been forwarded to the Executive Committee of University Council for consideration:

Proposal for a new Center of Virtual History

Proposal to offer the existing major in Biological Science (B.S.A.) as an external degree on the Tifton Campus

Proposal to offer a new major in Industrial-Organizational Psychology (M.A.Non-Thesis) as an external degree on the Gwinnett Campus

Proposal to offer a new Graduate Certificate in Multicultural and Diversity Studies in Educational Contexts

Proposal for the following changes from the College of Education:

Proposal to change the name of the major:

FROM: English Education (Ed.S.)

TO: Language and Literacy Education (Ed.S.)

Proposal to terminate the major in Reading Education (Ed.S.)

Proposal to terminate the major in Teaching Additional Languages (Ed.S.)

The committee approved a request for a new Area of Emphasis in American Literature under the major in English (A.B.).

The committee approved a request for two new prefixes: HAUS, Hausa, and KYRG, Kyrgyz.

The Provost discussed changes in Board of Regents procedures for reviewing new program proposals and the need for increased scrutiny of the budgets of new programs. Proposals for new programs will have to include additional information in response to these changes before they are submitted to the Board of Regents for consideration.

The committee discussed the routing of proposals for new Centers.

The committee discussed distance education and requested to be kept informed concerning the work of the Distance Education Advisory Committee.

Biological Sciences: Dr. Marsha Black

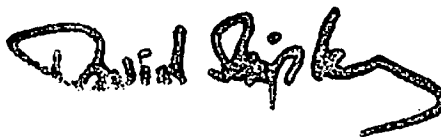
