The subcommittee approved the following course to fulfill the Experiential Learning Requirement and be included as an option on the Experiential Learning Transcript:

College of Family and Consumer Sciences

TXMI 5280, Retail Entrepreneurship (Category: Internship)

The subcommittee approved FORS(ANTH) 4270/6270, Field Studies in Recreation, Tourism, and Leisure (Category: Creative) from the Warnell School of Forestry and Natural Resources pending revisions to the CAPA non-traditional format field to reflect the language in the rubric. However, subsequent to the meeting, it was determined that FORS(ANTH) 4270/6270 was previously approved for the Global category in 2018 and the school decided they would like to retain the Global category for the course.
