- The College of Public Health submitted the following blanket statements as amendments to their Experiential Learning Implementation Plan:
 - Students in any major (or undeclared students in the College of Public Health) may fulfill the requirement by taking any courses from another UGA school or college list of approved courses for Experiential Learning.
 - Students in any major (or undeclared students in the College of Public Health) may fulfill the requirement by completing any non-course activity that has been approved for Experiential Learning at the university level.
 - Global: Students in any major (or undeclared students in the College of Public Health) may fulfill the requirement through participation in any UGA approved study abroad program.
 - Research: Students in any major (or undeclared students in the College of Public Health) may fulfill the requirement by taking undergraduate research courses through CURO.
 - Service: Students in any major (or undeclared students in the College of Public Health) may fulfill the requirement through any service learning course (denoted with an S-suffix).
