Requesting prefix: GLOB

Dear Professor Shipley:

We would like to request that a new prefix be established for global health courses to be housed within the College of Public Health. The courses using this prefix will be coordinated by the College's Center for Global Health. The prefix would be **GLOB** for Global Health. We have three currently approved courses, Global Health Systems (HPAM 8500), Global Health Systems – Nation Focus (HPAM 8550) and Introduction to Global Health Systems (HPAM 4200), which would be moved to the prefix. We are also planning to add a new undergraduate course, Introduction to Global Health and would propose calling it GLOB 3100. This course will be submitted through the standard University Council process under a separate cover. We already have a graduate certificate in global health and are planning to develop an undergraduate certificate in global health at the University under this prefix designation. Please let me know if you need further elaboration on this request.
