The College of Family and Consumer Sciences is requesting a prefix of **FACS** for courses offered by each department in the college yet considered a College course and not specific to one department. For example, we currently offer : FDNS 2000, HDFS 2000, HACE 2000, and TXMI 2000 which is Introduction to Family and Consumer Sciences. This is also the case with FDNS 5711, HDFS 5711, HACE 5711 and TXMI 5711 (Study Tour in Family and Consumer Sciences). We also have two new courses to propose that would work better as a FACS course rather than having each distinctive department prefix.
