Proposed Effective Date: Fall 2022

1. Justification: What is the academic justification for instituting the requirement?

With this proposal to change the entrance requirements for the B.B.A. co-majors in the Terry College of Business, the attempt is to reduce unnecessary barriers to students entering the college, as well as clarification of some language in the requirements.

2. Requirements: What specific entrance requirements are proposed?

- ~~Be enrolled at UGA.~~
- Applicants need not be registered for courses (“currently enrolled”) during the semester in which they apply, but they must be eligible for current enrollment at the University of Georgia.
- Have a 2.60 earned overall grade point average (transfer and UGA coursework combined; based on UGA academic record by application deadline).
- Be in good academic standing (2.00 or higher UGA GPA at application deadline or no UGA GPA for a new transfer student).

- ~~Completion of BBA General Education Core Curriculum I - VI (students may be enrolled in coursework that fulfills these requirements during the semester in which they are applying).~~

- Applicants need to have completed or be in the process of completing the BBA General Education Core Curriculum Area VI and have 58 hours completed or in progress.

OR

Applicants need to have completed or be in the process of completing the BBA General Education Core Curriculum Areas I - VI.

- Exemption or successful completion of [MATH 1113](#) or [MATH 1113E](#) or higher-level [MATH](#) course (passing grade or exemption must be posted to your UGA academic record by application deadline).
- Successful completion of [ACCT 2101](#) or [ACCT 2101E](#) or [ACCT 2101H](#) (passing grade must be posted to your UGA academic record by application deadline).
- Completed or currently enrolled in [BUSN 3000](#) or [BUSN 3000E](#) or [BUSN 3000H](#).
- Be enrolled in or completed the third (or higher) level of the same foreign language - e.g., SPAN 2001 (has completed or exempted SPAN 1001 and SPAN 1002). A minimum grade of "B" (3.0) is required in the foreign language courses.

3. Results: How will the proposed requirement solve the academic problems outlined in the justification?

The proposed change to the entrance requirements will offer greater flexibility to prospective applicants, help students enter and potentially graduate sooner, reduce confusion for students as it will apply the 58 hour rule to both the A.B. and B.B.A. admissions processes, and reduce admission burdens.
