# PROPOSAL FOR TERMINATION OF AN ACADEMIC PROGRAM

**Program Abstract:** These areas of emphasis were created to provide students in the Geography (A.B.) major with suggested course specializations for interest in food systems (Agro-Food Systems and Food Security), physical geography and environmental issues (Environmental Geography), climate change (Global Environmental Change), economic and political geography (Globalization, Politics, and Economy), or urban geography (Urban and Community Studies).

**1. State the reasons for termination of the programs, and provide copies of any relevant documents.**

The areas of emphasis under Geography (A.B.) have had low enrollment for multiple years, and the department's current course planning does not adequately support them as options for students moving forward. The faculty have decided to terminate all areas of emphasis under this major in order to focus more on the majors, minors, and certificates offered by the department.

Additionally, the content in the Area of Emphasis in Agro-Food Systems and Food Security is also offered in the Undergraduate Certificate in Local Food Systems, and the Undergraduate Certificate in Sustainability. The content of the Area of Emphasis in Urban and Community Studies is also offered in Undergraduate Certificate in Urban and Metropolitan Studies.

**2. What will be done to minimize the impact of the termination of the programs upon the personal and professional lives of the faculty and staff involved? Include specific information on: a) how faculty and staff will be notified of the termination, and b) how faculty and staff will be reallocated.**

There is no impact on faculty and staff by terminating these areas of emphasis. Faculty will continue to teach courses offered in the department's other programs.

**3. What will be done to ensure that termination of these programs does not weaken other programs (graduate, undergraduate, or professional) for which the department may be responsible?**

Terminating the areas of emphasis will allow faculty to focus on supporting the core courses in the department's majors and certificates. The terminations will not impact course offerings or any programs outside the department.
