Dear Dr. Broder,

The Agricultural Leadership, Education, and Communication (ALEC) Department proposes an area of emphasis in <u>Educational Studies in Agricultural Education</u> as an option under the Agricultural Education BSA major. Providing the Educational Studies in Agricultural Education area of emphasis will better meet the needs of students who do not intend to become public school teachers, rather seek careers in nonformal education such as Extension agents and sales and service representatives. Courses in the proposed option are better aligned with students' interests and needs in non-formal agricultural education.

In addition, changes to the teacher certification laws as directed by the Georgia Professional Standards Commission (GPSC) mandate that we create a non-teaching area of emphasis to satisfy the Council for Accreditation of Educator Preparation (CAEP) requirements. CAEP measures the number of students credentialed in our program compared to those who actually took teaching jobs in public schools and will penalize the department for disparities, thus, jeopardizing our accreditation status.

The GPSC requires students to complete and pass the edTPA assessment effective fall 2015 to be credentialed within GA. The edTPA assessment costs students \$300 to be scored; therefore, imposing a financial burden on those who have no interest in credentialing to teach. With the addition of the Educational Studies in Agricultural Education area of emphasis, students in the Agricultural Education BSA major will have the option to focus on agricultural education principles, while engaging in a program that is better suited for their career needs as non-formal educators.

In summary, the Educational Studies in Agricultural Education area of emphasis under the Agricultural Education BSA major is necessary to meet the evolving needs of students who do not intend to teach agriculture education as well as satisfying recent requirements by the GPSC and CAEP for teacher preparation programs.

#### **MAJOR REQUIREMENTS**
