To the Members of the College of Education Curriculum Committee

We are writing to establish a new course prefix, LLOD, for courses to be moved to our new program in Learning, Leadership and Organization Development within the Department of Lifelong Education, Administration and Policy.

The primary rationale for this new prefix is that we are redefining and reinventing the program in adult education, learning and organization development into two distinct program areas- one in adult education, and one in learning, leadership and organization development. As part of this redefinition, a number of courses, primarily those associated with our Master's degree and doctoral emphasis area of human resource and organization development will be moved to the new prefix. Having our own prefix will enable us to more clearly articulate and differentiate the two curricula.
