The University Curriculum Committee met on October 9, 2015, at 3:00 p.m. in Room 315 New College.

Minutes of the August 28, 2015, meeting were approved.

The committee approved the following proposals which have been forwarded to the Executive Committee of the University Council for consideration:

Proposal for a new major in Atmospheric Sciences (B.S.)

Committee on Facilities, Committee on Intercollegiate Athletics, Committee on Statutes, Bylaws, and Committees, Committee on Student Affairs, Curriculum Committee, Educational Affairs Committee, Executive Committee, Faculty Admissions Committee, Faculty Affairs Committee, Faculty Grievance Committee, Faculty Post-Tenure Review Appeals Committee, Faculty/Staff Parking Appeals Committee, Human Resources Committee, Program Review and Assessment Committee, Strategic Planning Committee, University Libraries Committee, University Promotion and Tenure Appeals Committee

After much discussion, the committee approved with friendly amendments a proposal for a new minor in Human Services. The friendly amendments include a name change from Human Services Leadership to Human Services and the addition of wording to allow students in the College of Family and Consumer Sciences to substitute an elective for ECHD 3030.

The committee approved a request for a new Area of Emphasis in Human Resource Analytics under the major in Management (B.B.A.).


The committee approved a request to revise the high-demand selection criteria for the major in Marketing (B.B.A.).
