The Experiential Learning Subcommittee met on March 26, 2024, at 4:00 p.m. via Zoom.

The subcommittee unanimously approved the minutes of the January 23, 2024, Experiential Learning Subcommittee meeting.

The subcommittee unanimously approved the proposal from the College of Veterinary Medicine for the following non-credit activity to fulfill the Experiential Learning Requirement and be included as an option on the Experiential Learning Transcript. The subcommittee recommended that additional language be included in the proposal that the activity requires a minimum of 180 hours.

College of Veterinary Medicine Professional Internship (*Internship*)

The subcommittee unanimously denied the proposal from the College of Veterinary Medicine for the following course to fulfill the Experiential Learning Requirement and be included as an option on the Experiential Learning Transcript. The subcommittee determined that the course does not meet the learning outcomes for the Experiential Learning Requirement.

POPH 3600, Advanced Topics in Wildlife Health (*Internship*)

The subcommittee unanimously approved the proposal from the Franklin College of Arts and Sciences for the following course to fulfill the Experiential Learning Requirement and be included as an option on the Experiential Learning Transcript.

FCID 4100, Humanities Internship Course (*Internship*)

The subcommittee unanimously denied the proposal from the Franklin College of Arts and Sciences for the following non-credit activity to fulfill the Experiential Learning Requirement and be included as an option on the Experiential Learning Transcript. The subcommittee determined that there was not enough evidence that the activity meets the learning outcomes of the Experiential Learning Requirement. The subcommittee recommended

that the activity proposal could be revised to specifically focus on the volunteer work and include a minimum of 45 hours of “service” programming.

Minority Student Science Association (*Service*)

The subcommittee unanimously approved the proposal from the School of Public and International Affairs for the following non-credit activity to fulfill the Experiential Learning Requirement and be included as an option on the Experiential Learning Transcript.

Diplomacy Lab (*Creative*)

The subcommittee unanimously approved the proposals from the Office of Public Service and Outreach for the following non-credit activities to be included as an option on the Experiential Learning Transcript.
