The subcommittee provisionally approved HIST 4990, Senior Seminar in History, to fulfill the Experiential Learning Requirement for the Franklin College of Arts and Sciences. This approval is contingent upon a course title name change to "Senior Thesis in History." Subsequent to the meeting, the title was updated and the course was approved.

The subcommittee denied the request to include POLS 4645E, Applied Civic Engagement, to fulfill the Experiential Learning Requirement for the School of Public and International Affairs. The subcommittee felt the course description lacked evidence of community engagement and was unable to identify sufficient experiential involvement.
