The subcommittee provisionally approved the requests to include the University Judiciary (Category: Leadership) and University Judiciary Executive Council (Leadership) non-credit activities as options on the Experiential Learning Transcript, pending additional language about formal feedback, an additional mentoring component, and clarification on the number of hours that students are trained. Subsequent to the meeting, these revisions were made and the non-credit activities were approved to be included as options on the Transcript.

The subcommittee denied the request from the College of Agricultural and Environmental Sciences for the CAES Ambassador Program to fulfill the Experiential Learning Requirement and to be included as a non-credit option on the Experiential Learning Transcript. The subcommittee requested the college

include more evidence of leadership activities, and how students are demonstrating leadership roles within the activity. John Maerz has offered to meet with the college to help them revise the activity.
